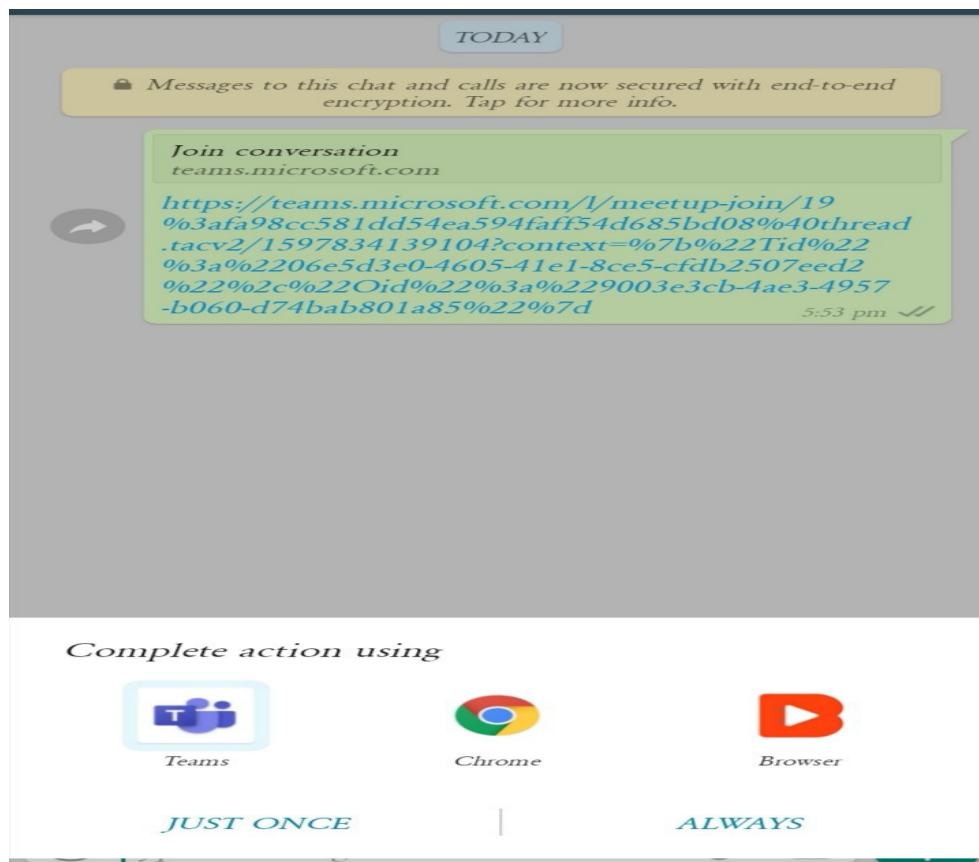
The said application is shown as:-

4. Now enter your name in “Name” box and click on Join meeting to Join the concernd Court Room.

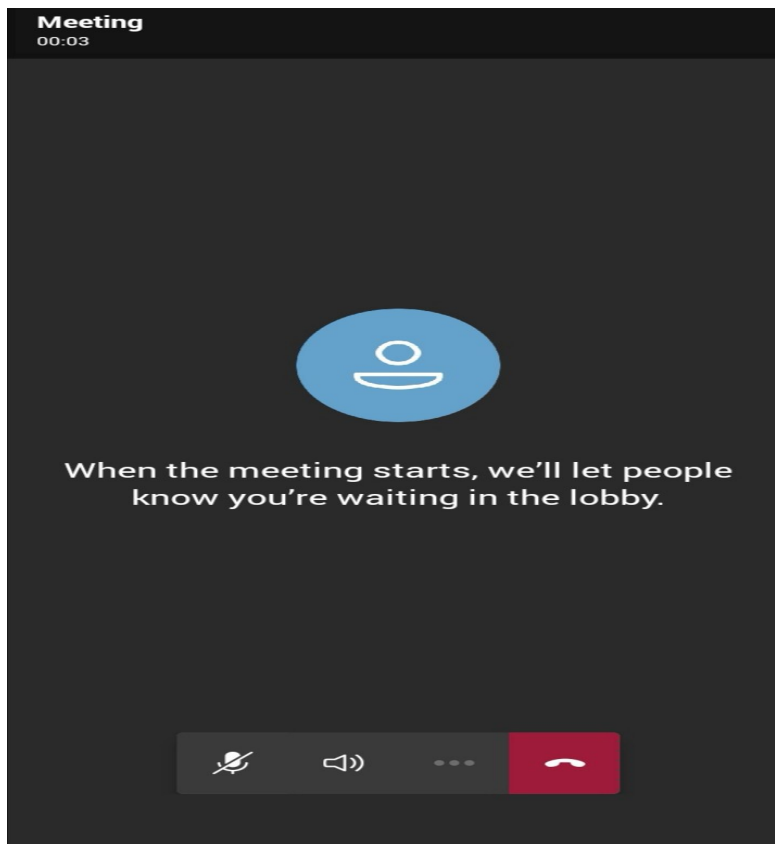
