

The terms and conditions of contract are as follows :



2. The Contractor shall have to enter into an agreement with the undersigned, Mandi with certain terms and conditions for cleanliness work.
3. The Safai Karamchari must be in proper uniform.
4. The Contractor shall quote the rates with or without the material for being used for cleanliness purpose.
5. The material which shall be used in the cleanliness work shall be of ISI mark.
6. The undersigned reserves the right to reject any or all the tenders, without assigning any reason.
7. The Tenderer shall have to furnish earnest money in the shape of a Bank Draft or Bank Guarantee @ 2% of the quoted amount and any tender received without requisite tender fee shall be liable to be rejected straightway.
8. The successful Tenderer shall also have to deposit the performance security within a week to the extent of five percent (5%) of the contract amount in the form of an account payee Demand Draft or duly pledged F.D.R. Such performance security shall remain valid for a period of 60 days from the date of completion of Contract to the best of satisfaction of the said office.
