Terms and Conditions:

1. Preference shall be given to an agency approved by the Central/State Govt.
2. Payment shall be made on full satisfaction of this authority after delivery and installation of the material necessary, subject to the rates as permissible by the Govt. of West Bengal.
 - a. Quotations must be submitted along with copy of PAN and GST registration.
3. The equipment supplied/replaced/repaired/installation shall be in compliance to the specification and shall be of competence or of best quality.
 - a. The supplier/bidder will be responsible for any damage during transit.
 - b. The contract shall be deemed terminated if the quality of the supplied equipment is not at par with the full satisfaction of this authority.
 - c. Warranty period, if applicable shall be mentioned in the quotations.
 - d. The Contactor shall be responsible to provide warranty / repairing for 2 years after replacement/installation.
4. The bidder must have experience of at least 3 years in execution of similar jobs in the Govt. Sector/any PSU and must have sufficient economic capability to execute the work and also must have successful proven track record to implement the work as prescribed.
5. The quotation containing the lowest rate including GST shall be accepted.
6. Different taxes such as GST, IT, etc. will be deducted at source as per rule of the Government.
