1. The Vehicle will be auctioned separately not through the lot.
2. The Vehicle will be sold on "As is where basis is". The auction process will be conducted by auction committee of the office. Taxes and duties that may be levied by government will be extra applicable.
3. The bidder may inspect the said vehicle from 30.09.2021 to 02.10.2021 on working days from 10.00am to 04.00pm and may contact the controller vehicle (Mobile No.- 9525621443). Interested person may also visit the court's website:- <https://districts.ecourts.gov.in/madhepura>
4. Every intending bidder will have to register themselves by way of depositing Rs.500/- in cash (Non-refundable) at least 30 minutes before the scheduled time of auction.
5. The successful bidder shall have to deposit 25% payment against their bid as soon as the bid is over. In case of failure to deposit the 25% amount after adjusting the security money on the spot. If highest bidder does not accept the offer of sale vehicle for any reason whatsoever it may be and withdraw from bidding, the EMD deposited by such bidder will be forfeited. The second highest bid amount may be considered for sale, if accepted by the District & Sessions Judge, Madhepura and accordingly the second highest bid amount will be considered as the highest bid amount or respective vehicle may once again be taken up for re-auction on the same day. The Officers of the court and their family members shall not be permitted to participate in the auction.

8. The Office will not owe any responsibility for transfer of vehicle and for any other liability for using this vehicle for commercial or any other purpose after sale.
9. Once the release order issues, this office will not be responsible either for safe custody or any loss or damage to the subject vehicle.
10. The highest bid once accepted is not transferable to anyone. In case the bidder is a company, the name of the company should be indicated as the bidder. In case such cases the persons appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.
11. The scheduled day for opening the sealed tenders due to any reason unforeseen arise, the same will be opened the next immediate holiday at 11.00 am.
12. The decision of the auction committee for all the purpose shall be final and binding.
