NOTIFICATION INVITING SEALED TENDER.

Sealed Tenders for sale of one number of Ambassador Car of District Court, Kendrapara bearing Registration **No.OR-05-C 8391** of 1995 model in running condition, invited by the undersigned so as to reach the under signed (through Regd. Post/speed post/courier service only) on or before **20.12.2017** during the working hours. The off set price of the above vehicle has been fixed at **Rs.25,000/-** . The tenderers should write in capital letters "NOT TO OPEN" on the top of the sealed envelope. The Earnest Money to be deposited (EMD) through Bank Draft will be refunded to all tenderers except whose Tender papers are accepted. The intending tenderers may inspect the vehicle put for sale and kept within the premises of the Civil Courts, Kendrapara on any working day between **10 A.M. to 5 P.M.** after taking prior permission from Add. Senior Civil Judge, Kendrapara.

The Earnest Money of **Rs.1000/- (Rupees One Thousand)** only should be deposited in shape of Bank Draft for the vehicle in favour of Registrar Civil Courts, Kendrapara which should be enclosed with the Tender papers while sending the same to the Addl. Senior Civil Judge, Kendrapara. The Tenders will be opened by the Addl. Senior Civil Judge, Kendrapara on 20.12.2017 at 4 P.M. in the presence of the tenderers or their Authorized Agents. The Addl. Senior Civil Judge, Kendrapara will examine the Tenders on the same day for finalization for sale which shall be subject to confirmation by the Competent Authority. The tenders received without the EMD and beyond the due date will not be taken into consideration. The delay in postal/courier transit in the receipt of Tenders shall not be taken into account and it shall be the sole responsibility of the intending tenderers concerned to take adequate precaution for

timely receipt of the Tender complete in all respects in the Office of the Addl. Senior Civil Judge ,Kendrapara.

The highest offer on being accepted, such tenderer shall have to deposit 25% of bid amount on the very day, the sale is confirmed failing which, the EMD shall be forfeited. The balance 75%of the bid amount is to be deposited by the tenderer within 7 days from the date of acceptance of the Tender and confirmation of the sale. Apart from, this, the successful bidder is required to deposit Tax as applicable on the sale value in shape of Treasury Challan and submit the original copy of the challan before release of the vehicle. The vehicle sold shall have to be removed from the Court premises within 7 days from the date of deposit of the entire amount failing which, ground rent at the rate of Rs.1%of the Tender amount shall be charged for each day which will be deposited in the Court's Cash Counter before removal of the vehicle .In case, the ground rent exceeds the sale price deposited, the party will cease to have any right over the vehicle. The amount deposited shall be adjusted towards the ground rent and the vehicle shall then become the absolute property of the Court, free from all encumbrances.

The Authority reserves the right to reject or accept any or all quotations without assigning any reason thereof.

Annexure-1

Terms and conditions for disposal of condemned vehicles against Tender Invitation No.

- 1.** The interested parties may submit their highest price for vehicle individually in a sealed cover latest by **04.00 P.M. on or before 20.12.2017**. The offered price for the vehicle shall not be less than offset price of Rs.25,000/- .
- 2.** The cover carrying the bid should be prominently super scribed in capital letter with **“QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE”**- bearing **Registration Number OR-05-C-8391”**.
- 3.** The disposal of vehicles shall be strictly on **“AS IS WHERE IS BASIS”** and no guarantee or certificate of its worthiness or quality will be given by this office. The condition of the vehicle can be inspected physically between 11.00 A.M to 04.00 P.M. on any working day between 07.12.2017 to 13.12.2017.
- 4.** The quotation should be accompanied by **earnest money of Rs.1000/-**. The earnest money is to be deposited by Demand Draft in favour of Registrar, Civil Courts, Kendrapara payable at SBI, Main Branch, Kendrapara. The demand draft should be attached with the quotation letter falling which the quotation shall not be considered at all.
- 5.** The highest bidder, whose bid is accepted, shall deposit immediately **25% of the offered amount then & there as initial deposit**. He shall deposit the balance amount within seven days of the deposit of the initial amount. In case, he fails to make deposit of the total amount as per the tender within stipulated time, the deposit including the earnest money shall be forfeited.
- 6.** The earnest money of successful bidder can be adjusted at the time of final payment of tender value in time. Tax as admissible shall be paid on the bidding cost by the successful bidder.

- 7.** The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status. (Ration Card/ Voter ID Card/Adhaar Card in case of individuals and Registration Certificate in case of firms etc.)
- 8.** The successful bidder shall remove the vehicle from the site within seven days of from the date of full payment. On failure to remove the vehicles within the aforesaid time span, ground rent @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle. If the ground rent so charged, exceeds the sale price deposit the bidder shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.
- 9.** The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
- 10.** The EMD (Earnest Money Deposit) of unsuccessful bidder shall be returned within three weeks of the award of contract to successful party.
- 11.** The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number and mobile number.
- 12.** Tendering form should be signed in ink by the authorized signatory only. Photo copy or unsigned quotations or quotations not signed by the authorized signatory shall be rejected.
- 13.** Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
- 14.** The undersigned reserve the right to reject all or any tender in whole or part without assigning any reasons thereof.
