With reference to the instructions of the Tamil Nadu Public Service Commission, Chennai cited in the reference, the individuals are directed to furnish Physical Fitness Certificate obtained from not below the rank of Civil Surgeon at the time of joining duty and in case of the differently-abled candidates, a certificate, with regard to the nature of disability, percentage of disability and their capacity to perform the duty, from the District Medical Board should be submitted by the individuals either at the time of joining duty or within one month from the date of joining duty.

With reference to the instructions of the Tamil Nadu Public Service Commission, Chennai, the individuals are informed that no representation will be entertained regarding joining time and that failure to join duty on the specified date and at the specified place will result in their name being deleted from the approved list.

If they have not registered, they should submit a declaration to that effect.

The Presiding Officers concerned, while permitting the individuals to join duty, should verify the identity marks of the respective individuals to ascertain the identity of the individuals.
