

CORRIGENDUM

EMPLOYMENT NOTICE FOR THE POSTS OF PROCESS SERVER AND PEON

Applications for two posts of Process Server (General Category-02) in the pay matrix of DL-16900-53500 and three posts of Peon(General Category-03) in the pay matrix of DL-16900-53500, purely on temporary basis for Fatehabad Sessions Division are hereby invited from the general public. The essential qualification for the aforesaid posts shall be as follows:-

Process Server

Appointment to the posts of Process Server shall be made from the candidates who have passed matriculation examination with knowledge of Hindi or Punjabi.

Peon

Appointment to the posts of Peon shall be made from the candidates who have passed middle standard examination and possess knowledge of Hindi or Punjabi

Age

The minimum age limit of candidate for appointment to the posts of Process Server and Peon shall be 18 years and upper age limit shall be 42 years as on 01.01.2019 in accordance with the latest instructions of the Haryana Government in this regard and age relaxation to reserved category candidates shall be in accordance with instructions issued by the Government of Haryana.
