Lawyers and parties to bring softcopies of the urgent matters in addition to hard copies and the documents so that, those documents can be seen by concerned courts while hearing of the matters.

The Superintendent of Police, Sangli is requested to direct all Police Station Officers in the Sangli District to follow the practice as suggested above.

Taluka Courts also follow the same practice, with immediate effect.
