**(Order No. 249 /2020)**

In view of the report dated 01-07-2020 received from Chief Medical Officer Ghaziabad through e-mail, Sri Sudesh Kumar, Reader Special Judge, Pocso Court No. 02, Ghaziabad has been tested positive Corona Virus .

Vide his report Chief Medical Officer Ghaziabad has opined for 24 hours closure of Civil Courts Ghaziabad.

Hon'ble Court vide letter No. 1117/LXXXVII-CPC /e-Courts/ Allahabad/ Dated 03-06-2020 regarding Mechanism / Modalities for opening of Civil Courts subordinate to Hon'ble High Court in para 15 has provided as follows:

" Where the District Administration/ CMO concerned is of the opinion that the District/ Outlying court campus should be closed for a particular period and / or the District Judge is of the opinion that the District Court/ Outlying court should be closed for particular period, then the District Court / Outlying Court may be closed for the said period and intimation mentioning the specific reason may be sent to Allahabad High Court."


Hence in compliance of mandate contained in para 15 of Hon'ble Court's letter No. 1117/LXXXVII-CPC /e-Courts/ Allahabad/ Dated 03-06-2020 for complete sanitization of Court campus all the Courts shall remain closed for 24 hours (i.e. on 02-07-2020). Meanwhile complete sanitization of Court Campus and chambers of Advocates be done under supervision of Shri Abhishek Srivastava, Addl. District & Sessions Judge, Court No. 10, Ghaziabad/Officer-in-charge Nazarat and Sri Ratnesh Deep Kamal Anand, Chief Judicial Magistrate, Ghaziabad and submit report by 03-07-2020 before 10 A.M.

Cases fixed on 02-07-2020 shall be taken on 18-08-2020 for hearing excluding Bail Applications.

Information be sent to the Hon'ble High Court Allahabad and also be uploaded on the official website of District Court, Ghaziabad.

A list of employees who have come in contact with Sri Sudesh Kumar be sent to Chief Medical Officer Ghaziabad for Covid testing.


