
Sir,

In the light of JHALSA Letter No. 2829 dated 30.07.2015 R/W Ref: No. JHALSA/3177 dated 19.01.2017 where by DLSAs were directed for making Payment of honorarium to Jail Inmates enrolled as PLVs. There are 06 Jail Inmates working as PLVs in Sub Jail, Khunti in the different Period namely 1. Durga Munda 2. Manoj Lugun 3. Rajni Kushum Munda 4. Mikhiyl Topno 5. Mira Khalkho and 6. Sanjay Purti. At present only Durga Munda and Sanjay Purti are working as PLVs and other four have already been released from Sub Jail, Khunti on different Dates.

As per report received from the office of Superintendent, Sub Jail, Khunti vide different letter numbers as Letter No. 94/ Khunti dated 30.01.2017, Letter No. 114/ Khunti/jail dated 03.02.2018 and Letter No. 140/ Khunti/ Jail dated 09.02.2018 regarding the attendance and performance of Jail PLVs duly Sealed and signed by the Superintendent, Sub Jail, Khunti have been received. As per aforesaid reports of Jail Administration the detailed working performance of Jail PLVs deputed at Legal aid Clinic, days wise and Month wise is annexed herewith on separate sheet for kind perusal of your good self.

As per Ref: No. JHALSA/1825 dated 01.07.2017 the PLVs are entitled to get honorarium of Rs. 250/- per working day till 30.06.2017 and entitled to get Rs. 400/- per working day from 01.07.2017.

Hence, the proposal may be put up before Hon'ble Chairman, DLSA, Khunti for approval of payment of honorarium to the Jail PLVs as per the chart attached from April 2015 to December 2017 of total Rs 1,05,950/- (Rs. One Lack Five Thousand Nine Hundred fifty only) from the NALSA fund.
