This Bail Petition is coming before me on this day filed by Thiru R.Prabhakar for Petitioner and APP for the prosecution side, heard bothsides perused the records and this court passed the following.

ORDER

This case was registered by the respondent police against the Petitioner / accused U/s. 392, 354, 427, 506(i), 294(b), 323, 341 IPC.

The Petitioner / accused was arrested and remanded to Judicial Custody on 26.09.2020. The counsel for the petitioner submitted that Petitioner / accused is innocent and he is no way connected with the allegation that has been level as against him in the present case.

Heard bothsides. Records Perused. Upon considering the fact of the case, Judicial Custody for the past 10 days for the alleged offence U/s. 392, 354, 427, 506(i), 294(b), 323, 341 IPC and whether the accused have committed the offence or not can be looked in the trial. The presumption of innocence is in favor of the petitioner / accused till the accusation is proved. Here the accusation is to be proved in the trial only.

Also memo filed by the petitioner/accused counsel stating that, A3 released on bail by the Honble High Court in CrI.O.P.No.10802/20 Dt:05.10.2020.

Considering the facts and circumstances, and period of judicial custody and also in the interest of justice, in my considered view of opinion is that both the accused can be released on bail by imposing suitable condition for his presence. Hence, I am inclined to enlarge the petitioner on bail on the following conditions.

1. The Petitioner / accused is directed to execute own bond for sum of Rs.10,000/-to the satisfaction of The Jail Superintendent, Central Jail, Theni District.
2. The Petitioner / accused shall surrender before this court and execute bond along with two sureties for Rs. 10,000/- each to the satisfaction of this court within a period of 15 days after the withdrawal of Lockdown.
3. The Petitioner / accused shall appear and sign before respondent police station daily at 10.00 A.M and evening 5.30 P.M until further orders after the withdrawal of lockdown.
