

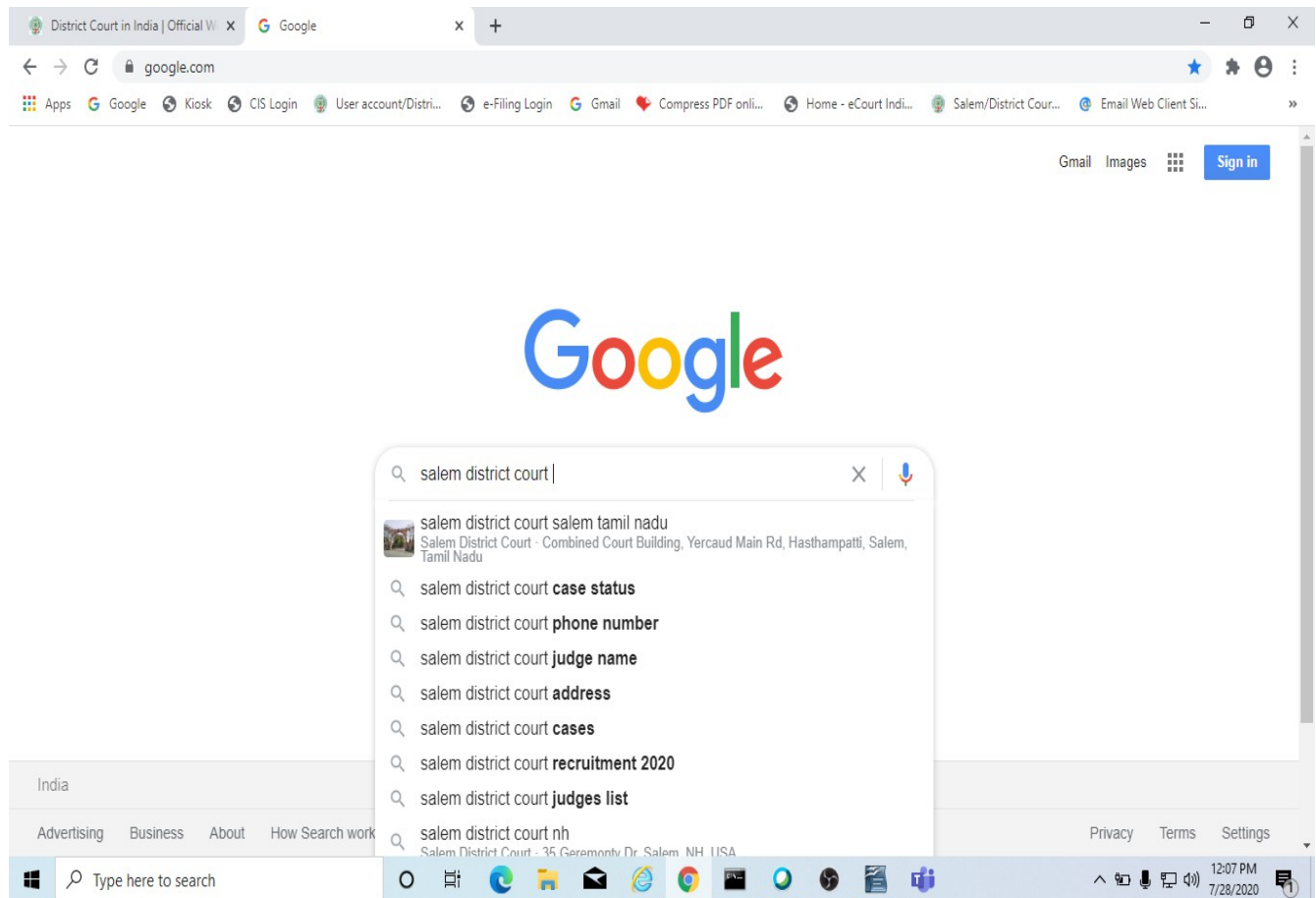
How to view the Bail Orders in the Salem District Court?

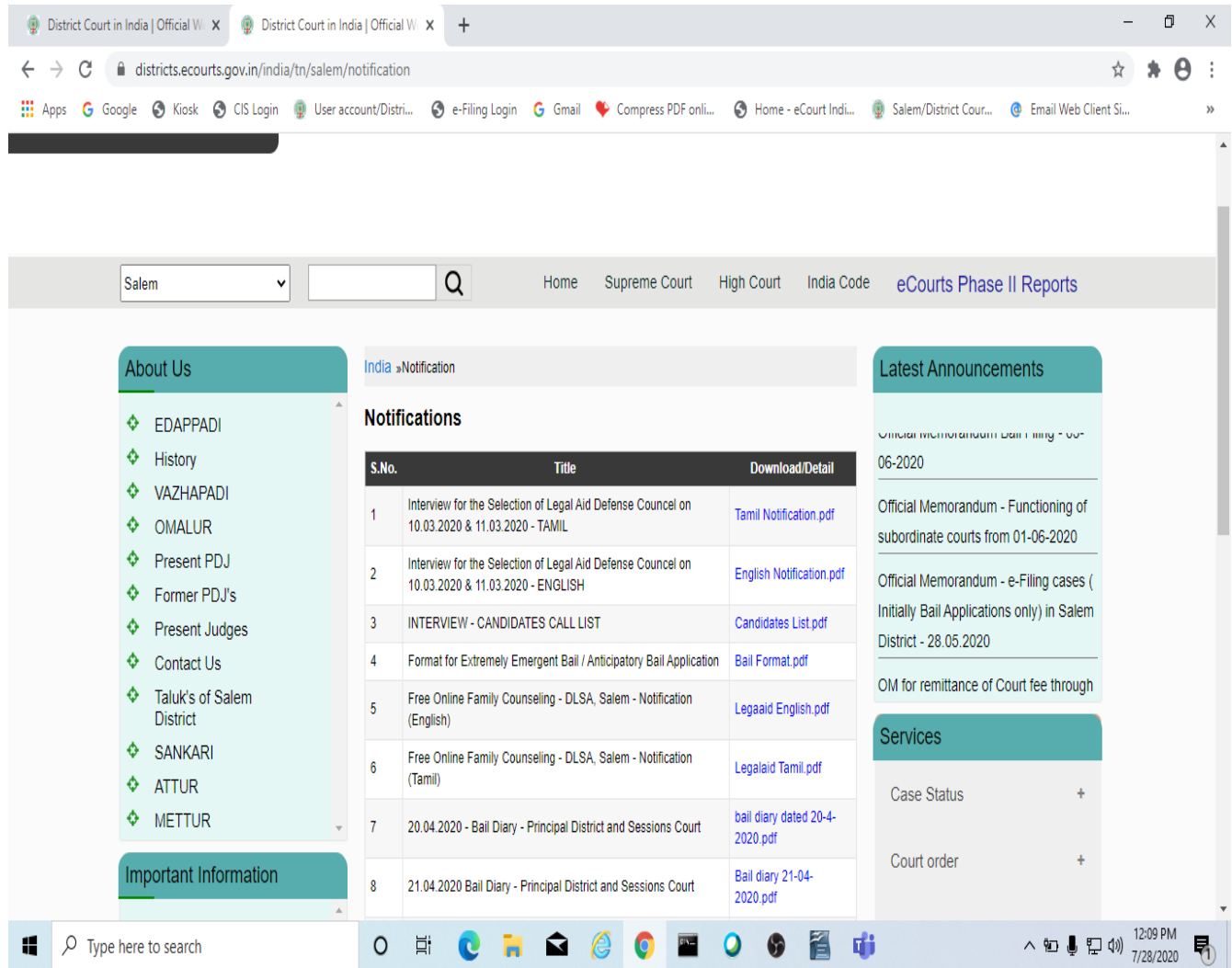
