In order to give effect to the Notification No.1597-RG dated 05/06/2020 of the Ld. - In Chandernagore and Serampore Sub-division the Judicial Officer in the rank of Additional District & Sessions Judge who will remain present shall also remain in charge of all the Additional District & Sessions Judge Courts including Additional District & Sessions Judge, Fast Track Court.
- In Arambagh Sub-division Ld. Additional District & Sessions Judge, 2nd Court, Arambagh shall remain in charge of Additional District & Sessions Judge, 1st Court, Arambagh as usual.
- Judicial Officer in the rank of Civil Judge (Sr. Divn.) shall remain in-charge of all the Courts of Civil Judge(Sr. Divn.) at Hooghly Sadar.
- Judicial Officer in the rank of Civil Judge (Jr. Divn.) shall also remain in-charge of all the Courts of Civil Judge(Jr. Divn.) at Hooghly Sadar, Chandernagore, Serampore and Arambagh Sub-division.
- All the Judicial Officers are requested to make an arrangement regarding attendance of one clerical staff and one Group 'D' staff **positively** on every working day **on rotation basis**.
