As per direction of Hon'ble Court's through e-mail dated-14th April,2020 and in continuation of this office earlier Order No.95/G dated Howrah, 09.04.2020, the following arrangement is made for hearing of all urgent matters (Civil/Criminal), and 'Duty Roster' of the Judicial officers, who will be detained on duty, during the period from 9th April,2020 to 30th April,2020. 
