Dated, 28th April,2020

As per direction of Hon'ble Court vide Notification No.1534-RG dated-24th April,2020 and in continuation of this office earlier Order No.97/G dated Howrah, 16.04.2020, the following arrangement is made for hearing of all urgent matters (Civil/Criminal), and 'Duty Roster' of the Judicial officers, who will be detained on duty, during the period from 1st May ,2020 to 15th May,2020. The officers on detention duty shall make themselves available, to meet the exigency of hearing any urgent matter or any other emergent purposes **as and when required.**

In view of the Judicial Department's G.O No. 5091(A1)-J/JD/4P-05/04(Pt) dated, Kolkata, 9th April,2020, the District Judge/ Additional District Judges taking up urgent bail /anticipatory bail applications will also take up urgent Criminal matters **under any /all Special Acts** including SC and ST (Prevention of Atrocities) Act, NDPS Act, TADA, Indian Electricity Act, Prevention of Corruption Act, POCSO Act, etc.
