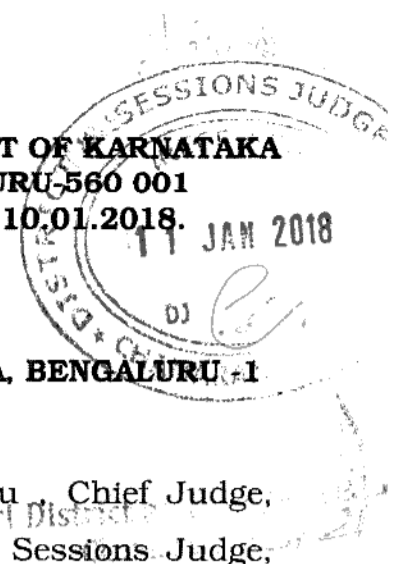

**Sub:** Request to forward the rectified Final Seniority lists of Sheristedars of the Subordinate Courts in the State from 01.04.1978 to 31.12.2016 if any defects found in your earlier Seniority list - reg.

I am to state that, the High Court has received the Final Seniority lists of Sheristedars submitted by you in the month of November 2017 with all the details of Sheristedars. The Hon'ble Committee after taking into consideration of the representations of 5 Districts namely, Vijayapura, Chikkamagaluru, Mysuru, Bidar and Bagalkot and other officials is of the opinion that opportunity has to be given to all the District Courts to rectify their final Seniority lists, as there are omissions and several defects in the earlier Seniority lists sent to the High Court. Hence, the Hon'ble Committee has resolved to direct all the Prl. District & Sessions Judges in the State as under:-

1. To include the names of the Sheristedars, if their names are not mentioned in the earlier seniority list and if any defects have crept in the lists submitted by all the Prl. District & Sessions Judges to the High Court and to make necessary rectification in the seniority by placing all the eligible Sheristedars according to their seniority.

2. Thereafter, all the Prl. District & Sessions Judges shall call for objections, if any, from the aggrieved Sheristedars, within one week, i.e., by 19th January, 2018.
3. The Prl. District & Sessions Judges shall consider the objections received from the aggrieved persons within one week, and they shall bestow their personal attention in preparing the final seniority list without giving room for any lapses. The Revised Final Seniority lists of Sheristedars shall be forwarded to the High Court without fail, by 27th January, 2018.
4. The objections from the aggrieved Sheristedars or any other officials shall not be entertained after the stipulated period of 07 days, i.e., 19th January 2018.

Therefore, while forwarding the Representations of the aggrieved officials and the lists of 152 Sheristedars and 34 Sheristedars (who are promoted as Chief Administrative Officers) to the concerned Districts, all the Prl. District & Sessions Judges in the State are hereby requested to comply with the directions of the Hon'ble Committee and forward the rectified Final Seniority list of Sheristedars to this office by 27<sup>th</sup> January 2018. Any representations or requests sent after 28<sup>th</sup> January 2018 will not be entertained.
