They should report in the Civil Court Premises, Cuttack half an hour before the commencement of Shorthand and Type Test alongwith their typewriter. They are required to produce their respective Intimation Letter issued to them for appearing in the written examination. In the event of non-receipt of Admit Card for Shorthand and Type Test to be held on 05.04.2015 at 10.00 A.M, the candidates are instructed to apply for issue of duplicate Admit Card on 03.04.2015 during office hour. The candidates are instructed to bring their Own Typewriter with them for their Shorthand and Type Test.

The candidate who will qualify in the Shorthand and Type Test shall appear Computer Test at 1.00 P.M onwards as per the Notification to be made after completion of Shorthand and Type Test on the same date. The duration of Computer Test shall be of one hour. After completion of Computer Test, the date and time for Viva-Voce Test of the qualified candidates will be notified on the same day.


