**THE TERMS & CONDITIONS OF THE CONTRACT ARE AS UNDER:**

1. The Contractor shall provide minimum one Safai Karamchari for each above office/Guest House for doing the cleanliness work i.e. cleaning, dusting and mopping etc. on each working day between 8.30 AM to 5.00 PM.
2. The Safai Karamchari must be in proper uniform.
3. The contractor shall quote the rates with or without material for being used for cleanliness purpose.
4. The tenderer shall have to furnish earnest money in the shape of bank draft or bank guarantee at the rate of 2% of the quoted amount and any tender received without requisite tender fee shall be liable to be rejected straight way.
5. The material which shall be used in the cleanliness work shall be of standard quality preferably ISI mark.
6. The earnest money of the successful tenderer shall be retained by the Committee for a period of one month from the date of acceptance of the tender and in case the work of cleanliness/ sweeping work is not found proper/ satisfactory then the earnest money shall be forfeited and the contract shall also be liable to be terminated.
7. The successful tenderer shall also have to deposit the performance security within week to the extent of five percent(5%) of the contract amount which shall be retained by the Committee for a period of two months from the date of its furnishing and if the work of cleanliness/sweeping is not found up to the mark then such performance security shall also be liable to be forfeited to this office besides exercising the option by this office for cancellation of contract.


8. The successful tenderer shall have to enter into a formal agreement with the Committee within a period of one week after acceptance of this tender and in case any of the party fails to enter into such agreement then the contract shall be liable to be terminated.
