

## OFFICE OF THE DISTRICT JUDGE, MURSHIDABAD

### TENDER NOTICE

Sealed tenders are invited from bonafide , reputed and interested persons for supply of power by generators in respect of the court of District Judge's Court ( entire compound) , Berhampore, Murshidabad ( each court comprises of Ejlash, Chamber & in some cases office also), Bungalow of District Judge, Murshidabad also, No which is noted below, on the following terms and conditions.

- 1) Rate for supply of Power by generator for each court per month should be mentioned in the tender following the Govt G.O.
- 2) The cost of hiring charge per month shall include hire charge operation and maintenance cost etc i.e. all connection charge.
- 3) The generator will be used at the time of load shedding during the office hours only.
- 4) All incidental charge for supply of power by hire generators will have to borne by the concerned party. This includes further wiring, if any, switches, boards, wire lines etc.
- 5) Costs of fuel for supplying power with Generators will be paid by the office over and above the monthly hire charges. The owner of the Generator has to buy the fuel for the generator and the same will be reimbursed after submission of the bill.
- 6) Hiring charge, including Mobil charge & fuel charge for the generator of District Judge's Bungalow will be paid at a fixed amount per month.
- 7) Temporary accommodation for placing of Generators will be provided by office ce but no responsibility for the safety and security of the Generators will be provided.
- 8) Rates for hiring Generators for supply of power with Generators must be submitted by the aforesaid persons of the locality/station of the courts concerned.
- 9) Tenders must be made by different persons for supply of power by Generators relating to one for all courts situated within the compound of District Judge's Court .( total 15 courts and 1 lock up) & separate generator for supplying of power to the bungalow of District Judge, Murshidabad.
- 10) Sealed cover containing the Tender must be written with the name of the station for which it relates.
- 11) The tender(s), whose Tender will be accepted, he/she must provide/supply power from generator w.e.f. 18.03.2016 positively.

The tenders will be received up to 4.30 pm of 14<sup>th</sup> day of March, 2016 by the office of the undersigned and will be opened on the same date at 5:00 PM by the undersigned or any authorised persons in presence of the Tenders or their representative who may remain present.

The District Judge, Murshidabad reserves the right to cancel any or all Tenders if any Tenderer fails to fulfil the terms and conditions mentioned herein.
