Sealed tenders in the prescribed format (Annexure-II) are invited from the intending bidders for disposal of the following condemned vehicle on "AS IS WHERE IS" basis on the terms and conditions set out in Annexure-I, mentioned below.

2. Firms/Persons interested to purchase the above mentioned vehicle may inspect the vehicle on any working days during office hours from 17/05/2017 to 25/06/2017 in Civil Court Premises before submitting the tender.

3. The sealed tender with your highest quoted prices (in Indian Rupees Only) for the vehicle listed above may be submitted in the prescribed proforma. Quotations may be submitted to the undersigned along with ***demand draft of Rs. 1,000/- as Earnest Money Deposit (EMD) for each vehicle*** drawn in favour of Registrar, Civil Courts, Cuttack payable at SBI, Main Branch, Cuttack as refundable security (EMD).

4. ***The highest quoted price for the vehicle shall not be less than the offset price mentioned against the vehicle in the above table.***

5. The cover carrying the bid should be prominently super scribed in capital letter with "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE"-
Mention here Registration Number of the vehicle for which bid has been offered.

6. The quotations addressed to the undersigned in sealed cover should reach this office latest by 05.00 P.M on or before 25.06.2017 by any means. Quotations received within the stipulated date and time will be opened on 26.06.2017 at about 11.00 A.M in the presence of bidders or their authorized agents, if anyone present. The undersigned will not held responsible regarding late submission of tender in any manner.

7. The sale against the tender shall be governed by the terms and conditions set out in Annexure-I to this invitation.

Annexure-I

Terms and conditions for disposal of condemned vehicles against Tender Invitation No.

1. Interested parties may submit their highest prices for the vehicle individually in a sealed cover latest by **05.00 P.M on or before 25.06.2017**. The offered price for the vehicle shall not be less than offset price mentioned against the vehicle in the above table.
2. The cover carrying the bid should be prominently super scribed in capital letter with **"QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE"- Mention here Registration Number of the vehicle for which bid has been offered.**
3. The disposal of vehicles shall be strictly on **"AS IS WHERE IS BASIS"** and no guarantee or certificate of its worthiness or quality will be given by this office. The condition of the vehicles can be inspected physically on any working day during office hour between 17.05.2017 to 25.06.2017 in the premises of Civil Courts, Cuttack.
4. The quotation must be accompanied by **earnest money** of **Rs. 1000/- for the vehicle**. The earnest money is to be deposited by **Demand Draft** favoring **Registrar, Civil Courts, Cuttack** payable at **SBI, Main Branch, Cuttack**. The demand draft should be attached with the quotation letter falling which the quotation shall not be considered at all.
5. The highest bidder, whose bid is accepted, shall deposit immediately **25% of the offered amount then & there as initial deposit**. He shall deposit the balance amount within seven days of the deposit of the initial amount. In case, he fails to make deposit of the total amount as per the tender within stipulated time, the deposit including the earnest money shall be forfeited.

6. The earnest money of successful bidder will be adjusted at the time of final payment of tender value in time. Vat as admissible shall be paid on the bidding cost by the successful bidder.

7. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status. (Ration Card/Voter ID Card/Adhaar Card in case of individuals and Registration Certificate in case of firms etc.)

8. The successful bidder shall remove the vehicle from the site within seven days of from the date of full payment. On failure to remove the vehicles within the aforesaid time span, ground rent @ 1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle. If the ground rent so charged, exceeds the sale price deposit, the bidder shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.

9. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.

10. The EMD (Earnest Money Deposit) of unsuccessful bidders will be returned within three weeks of the award of contract to successful party.

11. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number and mobile number.

12. Tendering form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by the authorized signatory shall be rejected.

13. Tendering firm shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.

14. The undersigned reserve the right to reject all or any tender in whole or part without assigning any reasons thereof.
